Subject:- Clarification in regard to import of bio-stimulants as raw material - regarding Sir.

I am directed to refer to the above mentioned subject and to say that in reference to the Bio-stimulant Notification dated 23rd February, 2021 and subsequent Orders and Clarification, some importers have raised the issue of custom clearance regrading import of bio-stimulants as a

It is clarified that bio-stimulants are being regulated under Fertiliser (Control) Order, 1985 vide this Department's notification dated 23rd February, 2021. However, the Form G-3 i.e. provisional registration or the permanent registration of these products is required for sale of Biofertilisers for direct application. Whereas if the Biostimulants are imported as raw material for sale to other Biostimulants manufacturers for use in formulation, there is at present no requirement for importers for obtaining the Provisional or Permanent Registration under FCO. However, in view of the difficulties expressed by Customs Department to differentiate between the products based on their use, it has been decided that the importers will give an undertaking to Customs Department, Department of Agriculture and Farrmers Welfare and the concerned State Government to the effect that the particular consignment of Biostimulant is being imported for use as raw material for supply to Biostimulant manufacturers.
